**Stock Market Review**: During the month of June 2018 KSE-100 (the benchmark) decreased by 2.18%, mainly attributed to the economic and political factors; however rumors that Pakistan could be placed on FATF's black list with associated economic & financial implications, continued heightened domestic political uncertainty ahead of upcoming general elections, and growing concerns over deteriorating external account imbalances and depleting foreign exchange reserves caused the market to slide. Moreover, Moody's downgraded Pakistan's credit rating from stable to negative, which created negativity among investors.

**Fund Commentary:** During the month under review, First Capital Mutual Fund's NAV has decreased by 7.24% as compared to decrease of 2.18% in KSE-100 (the benchmark), thereby underperforming the benchmark by 5.06%. The Fund underperformed the benchmark mainly on the back of low-weight in Banking, Fertilizer sector and zero-weight in Technology & Communication sectors.

During the month Banking, Oil & Gas Exploration and Production (E&P), Oil & Gas Marketing Companies, Fertilizer, and Technology & Communication sectors outperformed the market, while on the flipside Automobile Assemblers, Cement, Textile Composite, Power Generation & Distribution, Chemical, Engineering, and Pharmaceuticals sectors lagged the market. Foreign investors remained net-seller with the outflow of US\$73.244 million during the month under review, as compared to outflow of US\$17.416 million in previous month.
