Stock Market Review: During the month of August 2018 KSE-100 (the benchmark) decreased by 2.27%, mainly attributed to the lack of clarity on government policies regarding both external financing and fiscal side as macro-economic concerns took a toll on investor's sentiments. Weak corporate results and crisis in emerging economies added to the negativity.

During the month Automobile Assembler, Chemical, Glass & Ceramics, Oil & Gas Marketing Companies, Oil & Gas Exploration, Technology & Communication, and Textile Composite sectors outperformed the market, while on the flipside Commercial Banks, Engineering, Pharmaceuticals, Power Generation & Distribution, and Refinery sectors lagged the market. Foreign investors remained net-seller with the outflow of US\$67.374 million during the month under review, as compared to outflow of US\$63.701 million in previous month.

Fund Commentary: During the month under review, First Capital Mutual Fund's NAV has decreased by 3.29% as compared to decrease of 2.27% in KSE-100 (the benchmark), thereby underperforming the benchmark by 1.02%. The Fund underperformed the benchmark mainly on the back of low-weight in Chemical, Glass & Ceramics and Technology & Communication sectors as compared to the benchmark.
