Market Review: During the month of July 2021 KSE-100 (the benchmark) posted a loss of 0.64%. The market remained range bound during the period under review, on the back of concerns about widening current account deficit, increase in covid-19 cases of delta variant and civil war in Afghanistan and its possible effect on Pakistan.

During the month under review Auto Assemblers, Chemicals, Commercial Banks, Fertilizers, and Textile Composite sectors performed better than other sectors while on flipside Cement, Engineering, Glass & Ceramics, Oil & Gas Exploration, Oil & Gas Marketing Companies, Paper & Board, Pharmaceuticals, Power Generation and Distribution, and Refineries sectors remained the underperformers.

Foreign investors remained net seller with the outflow of US\$ 28.60 million during the month under review, as compared to outflow of US\$ 31.86 million in previous month.
