**Market Review:** During the month of February 2023 KSE-100 (the benchmark) decreased by 0.40% to close the month at 40,510 points. During the start of the month the market remained positive on the back of clearance of gas circular debt. However, the gains were wiped out as Pakistan faced delays in reaching a staff level agreement with IMF. The index remained under stress as bond yields rose to unprecedented levels in the secondary market creating expectations of further interest rate hike in the upcoming monetary policy. During the month Auto Assembler, Cements, Commercial Banks, Food & Personal Care, Glass & Ceramics, Paper & Board, Pharmaceuticals, and Power Generation & Distribution sectors outperformed market. On the other side, Cable & Elec. Goods, Insurance, Oil & Gas Exploration Companies, Oil & Gas marketing Companies, Refinery, Sugar & Allied, Textile Composite, Tobacco, and Transport sectors lagged the market. Foreign investors remained net buyer with the inflow of US\$ 8. million during the month under review, as compared to inflow of US\$ 8.74 million in previous month.
