Market Review: During the month of April 2023 KSE-100 (the benchmark) increased by 3.95% to close the month at 41,581 points. The month closed on positive note on the back much awaited commitments from the friendly countries which remained one of the pivotal step for the resumption of stalled IMF program. Moreover, positive development on economic front with Current Account and strong corporate profitability despite tough economic environment further boosted the investor's sentiments.

During the month Auto Assembler, Auto Parts & Access., Cable & Elec. Goods, Cements, Engineering, Food & Personal Care, Glass & Ceramics, Insurance, Leather & Tanneries, Miscellaneous, Oil & Gas Marketing, Paper & Board, Pharmaceuticals, Power Generation & Distribution, Sugar, Technology & Communication sectors outperformed market. Foreign investors remained net seller with the inflow of US\$ 0.08 million during the month under review, as compared to inflow of US\$ 9.08 million in previous month.

Investment Objective: The objective of First Capital Mutual Fund is to augment wealth of investors through investments geared towards securing maximum returns while simultaneously offsetting resultant risks through efficient diversification across sectors with low correlation amongst them.
